The plans, specifications, and contract documents for the above referenced project are hereby modified as follows:

1. Notice to Bidders – NB-1.
DELETE: Item 1 of scope.
ADD: 1. Two (2) 125 kW diesel powered generators and one (1) 150 kW diesel powered generator complete with concrete pads, automatic transfer switches, and related appurtenances.
CLARIFICATION: Revised the number of generators for each size to be consistent with electrical drawings.
2. Proposal – P-1 thru P-3.
DELETE: Pages P-1 thru P-3 in their entirety.
ADD: Revised P-1 thru P-3.
CLARIFICATION: Revised the Well No. 6 generator size.
3. Detail – Generator Installation – E10.
ADD: The Contractor shall provide a full tank of diesel for each generator prior to startup and load bank testing. This shall be subsidiary to the various pay items.

The undersigned, as bidder, declares that the only person or parties interested in this proposal as principals are those named herein; that this proposal is made without collusion with any other person, firm, or corporation; that they have carefully examined the form of Contract, Notice to Bidders, and Specifications herein referred to, and has carefully examined the locations, conditions, and classes of materials of the propose-1d work; and agrees that they will provide all the necessary labor, machinery, tools, apparatus, and other items incidental to construction, and will do all the work and furnish all the materials called for in the Contract and Specifications in the manner prescribed therein and according to the requirements of the Engineer as therein set forth.

It is further agreed that the quantities of work to be done at unit prices and materials to be furnished may be increased or diminished as may be considered necessary, in the opinion of the Engineer, to complete the work fully as planned and contemplated, and that all quantities of work, whether increased or decreased, area to be performed at the unit prices set forth below except as provided for in the Specifications.

It is further agreed that lump sum prices may be increased to cover additional work ordered by the Engineer and agreed to by the Owner, but not required by the Specifications, in accordance with the provisions of the General Conditions. Similarly, they may be decreased to cover deletion of work so ordered.

It is understood and agreed that the work is to be completed in full within **two hundred seventy (270) calendar days** beginning on the date stated in the Agreement. Bidder further agrees to pay as liquidated damages, the sum of **\$500.00** for each consecutive calendar day thereafter as provided in the General Conditions.

Accompanying this proposal is a certified or cashier's check or bid bond, (5% of greatest amount bid) payable to the **RPM WSC** for:

The bid security accompanying this proposal shall be returned to the bidder, unless in case of the acceptance of the proposal the bidder shall fail to execute a Contract and to file a Performance, Payment, and Maintenance Bond within fifteen (15) days after its acceptance, in which case the bid security shall become the property of the RPM WSC, and shall be considered as payment for damages due to delay and other inconveniences suffered by the Owner on account of such failure of the bidder. It is understood that the RPM WSC reserves the right to reject any and all bids and to waive any informalities in the bidding.

In the event of the award of a Contract to the undersigned, the undersigned will furnish a Performance and Payment Bond and Maintenance Bond for the full amount of the Contract to secure proper compliance with the terms and provisions of the contract, to insure and guarantee
